#### 1. IMPORTANT NOTES

LETTERS OF OFFER WILL BE ISSUED ONLY TO A VALID EMAIL ADDRESS ENTERED IN YOUR ONLINE APPLICATION. THE UNIVERSITY WILL NOT BE HELD RESPONSIBLE FOR A WRONG ENTRY OF EMAIL ADDRESS.

#### 2. GENERAL

- 2.2 Applications are invited only for those programmes that are ADVERTISED ON THE UNIVERSITY WEBSITE.
- 2.3 Due to COVID-19, candidates should send a copy of their signed application form (i.e Form A, where all selected programmes are listed), together with their qualifications by e.mail: applicationsubmission@uom.ac.mu
- 2.4 Applicants will not be required to call at the University for application procedures and should consult the Online Application System.

Candidates who are in their final year and who will graduate by July 2020 may submit their application and may be considered for a conditional offer. They should submit, together with their Application Form, a copy of their latest transcript showing their module grades and their CPA.

#### Mature Candidates

Mature candidates who do not meet the minimum entry requirements may apply for all taught Postgraduate Programmes. If they wish to be considered as Mature Candidate, it is compulsory that they tick the box at <u>Section 16</u> of the Application Form and attach documentary evidence with regard to work experience (only those who have filled in this section and submitted the requested documents will be considered for admission as Mature Candidates). The University reserves the right to review General Fees, Tuition Fees and other charges for any given academic year prior to the beginning of such academic year. By accepting a seat at the University, the student undertakes to pay all such fees as and when claimed.

#### NOTE

- A non-refundable application fee of Rs1,500 is payable before the application can be processed.
- Tuition Fees are exclusive of General Fees
- Please note that the following Direct Debit facilities (bank standing order) will be available for settlement of Total Fees and upon request. If you avail yourself of this facility, you will be required to settle your fees as follows:
  - (i) Payment of 25% of Total Fees on registration date.
  - (ii) Balance of 75% of Total Fees to be paid in <u>3 equal and consecutive monthly instalments</u>. Payment is to be made as from the end of the following month after registration. A Standing Order Form will be available at the Finance Director's Office during the registration exercise. The form duly filled in, should be submitted before registration. <u>In case of revocation of the Standing Order before its termination, you will not be admitted to the examinations as per University regulations.</u>
- If offered a seat at the University of Mauritius, a person, at registration, shall pay all required fees or produce written evidence
  of sponsorship by employer.
- A student who does not pay all fees and charges as required shall be suspended from the University and may only be readmitted with the permission of the Vice-Chancellor and on such terms and conditions as may be prescribed.
- Certificates of Graduands will be withheld as long as the graduands have not cleared all their liabilities towards the University.
- Upon registration the Students' Welfare Fund Fee must be paid by all students whether sponsored or not.

#### 6. SUBMISSION OF APPLICATION

- Application must be submitted online. Complete instructions for submitting online applications are available via the internet on the website <a href="http://apply.uom.ac.mu/application">http://apply.uom.ac.mu/application</a> up to <a href="https://apply.uom.ac.mu/application">Friday 31st July 2020</a> and all procedures and instructions should be clearly followed.
- 6.2 Candidates should send a copy of the signed Online Application Form together with their qualifications and Part B of the Cash Deposit Voucher or any Proof of Payment representing the non-refundable application fee of Rs1,500 by e.mail: applicationsubmission@uom.ac.mu

# Deadline for Payment at the Bank is Tuesday 4th August 2020.

#### N.B.

- (i) Applications received after the closing date or incomplete applications or not supported by the Application Fee of Rs1,500 will not be considered.
- (ii) Applications not submitted on the prescribed online forms will not be considered.
- (iii) Prospective applicants are informed that the University reserves the right not to run any one of the advertised programmes should there be an insufficient number of students registered for it.
- (iv) So as to remove any possible doubt, prospective applicants are informed that the University is under no obligation to find employment eventually for successful applicants.
- (V) Qualifications obtained after the closing date should be submitted as soon as possible.
- (v) The University reserves the right to amend the Programme Structures and individual modules, as well as the offer of modules during the duration of a course at any time with reasonable notice, by letters circulated through the Programme Coordinator and email to students concerned at least one month prior to the implementation of the amendment(s) made.
