BSc (Hons) Social Work Practice – SH354 (Full-Time) (Under Review)

1. Context and Objectives

The BSc (Hons) Social Work programme aims to prepare school leavers wanting to develop a career in social work with solid and rigorous theoretical and practical knowledge and skills in generic social work methods and interventions in line with the International Code of Ethics for social workers.

Students are empowered to develop:

- A multidisciplinary approach to social work practice through an understanding of social science, social welfare and management science theories for effective and forward looking professional social work practice;
- A reflective and reflexive approach to professional social work practice;
- Sensitivity towards issues related to cultural diversity, social oppression, social injustice and social inequality among others;
- Their ability to link academic learning to practice
- Research skills for evidence-based social work practice;
- Commitment to social work mission, values and ethics;
- A critical understanding of international and local professional social work practice;
- And further their knowledge and skills for postgraduate studies in social work and related fields of practice.

2. Learning Outcomes

At the end of the programme, students will be able to:

- work as professional social workers in generic settings;
- embrace the values and ethical standards of the profession;
- develop sound theoretical knowledge in related social sciences disciplines;
- locate the social work profession within the social sciences;
- acquire social work theoretical knowledge;
- link theory to the practice of social work;
- use rigorous evidence-based research methods to assess social problems;
- interpret research findings;
- develop social work intervention strategies;
- apply professional social work skills and techniques;
- implement evidence-based policy making:
- take up leadership roles in the social field;
- analyse, formulate and implement social policies;
- analyse and develop social protection and social welfare programmes;
- develop community-based intervention strategies in line with the SDGs;
- devise and manage sustainable community development projects;
- develop CSR initiatives;
- network with civil society organisations.

3. Teaching and Learning Methods

Learning will take place in a range of different settings, from scheduled teaching in lectures and small group tutorials, to self-study and peer group learning (for example preparing and delivering presentations with classmates), case studies, role plays and field practice, including

study visits and work placements in social work agencies. Occasional guest lectures from local and international practitioners and academics may be called upon to contribute to the learning experience of students.

7. Assessment and Deadlines

Some modules may be assessed by continuous assessment alone.

Study visits and professional social work practical placements modules are not examined but assessed through the submission of a report.

2 LCCS credits and 6-LCCS credits modules will be examined at the end of the semester.

- Continuous Assessment: 40%

The continuous assessment will count for 40% of the overall percentage mark of the module, except for a module where this programme structure makes for other specific provisions(s).

Continuous assessment may be based on seminars and/or assignments and should include at least (2) assignments either/or tests for yearly modules. For semester modules, course work will comprise of either one of the following:- seminars, class tests or assignments.

An overall total of 40% for combined continuous assessment and written examination components would be required to pass the module, without minimum thresholds within the individual continuous assessment and written examination.

Students are required to submit work for continuous assessment by due dates. Failure to do so will normally incur penalties.

- Examinations

Modules will be examined in written form (*unless specified otherwise*) either at the end of the semester or at the end of the academic year subject to their credit weightage. The written examination will count for the remaining 60% of the overall percentage mark of the module, except for a module where this programme structure makes for other specific provisions(s).
