POST OF PRO-VICE-CHANCELLOR (ACADEMIA)

The Council of the University of Mauritius invites applications from suitably qualified and experienced candidates for the post of **PRO-VICE-CHANCELLOR (ACADEMIA)**.

Founded in 1965, the **University of Mauritius (UoM)** has evolved into a leading national institution with growing international standing. The University comprises seven (7) Faculties, namely: **Agriculture; Engineering; Information, Communication and Digital Technologies; Law and Management; Medicine and Health Sciences; Science; and Social Sciences and Humanities**, supported by five (5) Centres and a Doctoral School. UoM has a staff complement of approximately **900** and a student population of about **12,000**, reflecting its pivotal role in higher education, research, and national development.

The **Pro-Vice-Chancellor (Academia)** will report to the Vice-Chancellor and will be responsible for overseeing all academic affairs and activities relating to teaching and learning, research, academic planning and quality.

AGE

Candidates should not have attained the age of **60 years** by the closing date of applications.

TENURE

The appointment will be for an initial period of three (3) years which may be extended for a further period not exceeding three (3) years [to a maximum total of six (6) years] by Council on evidence of excellent performance.

CONDITIONS OF SERVICE

The post is remunerated, as per PRB 2026 (UOM 73).

APPLICATION PROCEDURES

Interested candidates are invited to submit their applications **by email**. The application letter and all supporting documents, duly signed and scanned through, should be sent to the following email address: application2026@uom.ac.mu

The application should include the following:

1. A letter of motivation;
2. Detailed and updated Curriculum Vitae, signed and dated by the candidate;
3. A written proposal, not exceeding 2000 words, about their vision for the University of Mauritius. Candidates shortlisted for interviews will have to present and defend their vision to the Selection Committee.
4. Name and Address of **three (3)** Referees. The Referees should be requested by the applicant to forward their Referee's Reports directly to the **PRO-CHANCELLOR AND CHAIRPERSON OF THE UNIVERSITY OF MAURITIUS COUNCIL** at application2026@uom.ac.mu under confidential cover **by the closing date of applications, i.e. Friday 03 April 2026**. Referees should attest to the candidate's high academic standard, managerial capacity and moral uprightness.
5. Copies of their birth, educational and academic certificates;
6. Copy of either their National Identity Card or the first and second pages of their Passport.

Note: Failure to provide any of the above documents will automatically disqualify the applicant.
