### Call for Expression of Interest (EOI) Provision of Accommodation to International Students

The University of Mauritius (“UoM”) invites Expressions of Interest (EOI) from suitably qualified and experienced service providers for the provision of accommodation to international students.

The objective of this EOI is to identify and shortlist potential providers capable of offering safe, secure, and suitable accommodation facilities to international students during their period of study at the University.

Selected providers may be required to offer accommodation services including, but not limited to:

- Furnished residential units, dormitories, or rooms;
- Essential amenities (Wi-Fi, laundry facilities, kitchen access, common areas, etc.);
- Maintenance and upkeep of premises;
- Adequate security arrangements to ensure safety of residents;
- Compliance with all applicable health, safety, and regulatory requirements;
- Any additional services that enhance student welfare and living standards.

Interested parties must satisfy the following minimum requirements:

- Be a legally registered entity or individual operating in Mauritius;
- Demonstrate ownership or legal right to manage the accommodation premises;
- Provide evidence of compliance with applicable laws and regulations (including safety, health, and zoning requirements);
- Possess relevant experience in providing accommodation services;
- Have no adverse record that may affect their suitability to provide such services.

Applicants are required to submit the following information:

- Company/individual profile;
- Description and location of accommodation facilities;
- Details of amenities and services offered;
- Photographs and/or layout plans of the premises;
- Evidence of compliance with applicable safety and regulatory standards;
- Any relevant experience in similar services;
- Contact details of authorised representative.

All EOIs must be submitted **not later than 17 April 2026**. Late submissions will not be considered.

EOIs will be evaluated based on, inter alia:

- Suitability and quality of accommodation;
- Location and accessibility to the University;
- Compliance with safety and regulatory standards;
- Experience and reliability of the provider;
- Overall value offered to students.

The University may conduct site visits to verify the suitability of the proposed accommodation.

This EOI is a preliminary step to identify potential service providers. Shortlisted applicants may be invited for further discussions, inspections, or to enter into a more formal arrangement with the University, where applicable.

The University does not guarantee that any applicant will be selected or that any agreement will be concluded.

All accommodation facilities must comply with applicable laws, regulations, and standards, including but not limited to:

- Health and safety requirements;
- Fire safety regulations;
- Local authority permits and approvals.

The University reserves the right to exclude any provider not meeting minimum standards.

All personal data submitted shall be processed in accordance with the Data Protection Act 2017. Information provided will be used solely for the purposes of this EOI exercise.

This call for Expression of Interest does not constitute a contractual offer or commitment by the University of Mauritius.

The University reserves the right, at its sole discretion, to:

- accept or reject any or all EOIs;
- request additional information from applicants;
- modify or cancel the EOI process at any time;
- shortlist applicants without providing reasons; and
- not proceed with any subsequent arrangement.

The University shall not be liable for any costs incurred by applicants in preparing or submitting their EOI.
